According to Zulfahnur (1967, p. 72) Literal novel is mentioned as serious novel because seriousness or depth in problems of reality in human is expressed by the author. So, this novel provides problems of human reality seriously, philosophy, and eternal (enduring) that has advantage for completing and learned of human reality, beside spell of entertain and enjoyable of story. So, reader can read about serious story in seriously although there are many contents of story which are full with spell of entertain and enjoyable of story in the novel.

In other hand, a novel has many aspects in the story. So that reader can know and understand about the content of the story in novel easily. There are some easy ways that make reader to get content of the story in novel. Rhetorical patterm and plot are part of aspects that can help reader to know and understand easily about it.

Rhetorical pattern is one of the art of using attractive writing style; beautiful and effective word choices with the goal of influencing the reader . Hence, rhetoric is an important element utilized in the writing of an author to gloss up his works as well as to win over his audience. The understanding of this concept guides the writer to make a study in linguistic field with novel Third Girl that is created by author Agatha Christie.

The rhetorical pattern analysis of persuasive narratives can be used to investigate rhetorical styles of texts. A stylistic sub-genre which play tricky 'games' with its readers frequently found in detective novel (Alexander, 2009, p. 13). The texts in Christy's novels contain rhetorical persuasion to convince a reader of the logical and necessary truth of Hercule Poirot's arguments which is not easy to understand. His creator Agatha Christie is one of the greatest readermanipulators to be found in the various genres of fiction; Although her story gives a lot of clues, the reader is in the dark until the detective points the way.

A great deal of the pleasure can be found in reading the stories which is derived from the final *dénouement*. The detectives in her novels, and Poirot in particular, find themselves attempting to convince a reader and the other characters present of the truth of an often complex solution. They need to convince the reader, and convince them well, through the sheer force of their argument. These stories are therefore ideal examples of texts to be analyzed through a study of rhetorical structure, and in particular by the use of Rhetorical Structure Theory. In the novel, the readers must know how is the plot of the novel. So that the readers can get the content of the novel to understand the story of the novel easily and also not make the reader confuse about what the writer has been written. The readers will know that the story of novel based on plot analyzing. Because plot is a literary term defined as the events that make up a story, particularly as they relate to one another in a pattern, in a sequence, through cause and effect, how the reader views the story, or simply by coincidence.
