A perlocutionary act is when we perform and act to say something, and an illocutionary act is when we have particular consequences on the hearer as a result of the interaction.

According to Champoux (1999), using movies can be a good teaching resource. analysis of language in Movie scripts can offer a fascinating window into the complexities of human communication, especially when placed in
