PENGARUH KOMPETENSI APARATUR DESA, TRANSPARANSI, DAN AKUNTABILITAS TERHADAP PENGELOLAAN ALOKASI DANA DESA DI KECAMATAN BANYUASIN I

Penelitian ini bertujuan untuk menganalisis pengaruh kompetensi aparatur desa, transparansi, dan akuntabilitas terhadap pengelolaan alokasi dana desa di Kecamatan Banyuasin I. Penelitian ini menggunakan metode kuantitatif dengan teknik pengumpulan data melalui kuesioner yang disebarluaskan kepada 99 responden yang terdiri dari kepala desa, perangkat desa, dan ketua Badan Permusyawaratan Desa (BPD) di 11 desa. Data dianalisis menggunakan bantuan Perangkat lunak SPSS 25 melalui uji validitas, reliabilitas, uji asumsi klasik, uji t, uji F, dan koefisien determinasi (R^2). Hasil penelitian menunjukkan bahwa secara parsial kompetensi aparatur desa, transparansi, dan akuntabilitas berpengaruh positif dan signifikan terhadap pengelolaan alokasi dana desa. Secara simultan, ketiga variabel tersebut juga berpengaruh positif dan signifikan terhadap pengelolaan alokasi dana desa. Temuan ini mengindikasikan bahwa peningkatan kompetensi aparatur desa, keterbukaan informasi, dan pertanggungjawaban publik sangat penting untuk mewujudkan pengelolaan alokasi dana desa yang efektif, transparan, dan akuntabel.

ABSTRACT

THE INFLUENCE OF VILLAGE APPARATUS COMPETENCE, TRANSPARANCY, AND ACCOUNTABILITY ON THE MANAGEMENT OF VILLAGE FUND ALLOCATIONS

This study aims to analyze the influence of village apparatus competence, transparency, and accountability on the management of village fund allocation in Banyuasin I District. This study uses a quantitative method with data collection techniques through questionnaires distributed to 99 respondents consisting of village heads, village officials, and heads of Village Consultative Bodies (BPD) in 11 villages. Data were analyzed using SPSS 25 software through validity tests, reliability tests, classical assumption tests, t tests, F tests, and coefficients of determination (R^2). The results of the study indicate that partially village apparatus competence, transparency, and accountability have a positive and significant effect on the management of village fund allocation. Simultaneously, these three variables also have a positive and significant effect on the management of village fund allocation. These findings indicate that increasing village apparatus competence, information transparency, and public accountability are very important to realize effective, transparent, and accountable management of village fund allocation.
